**New Business:**

**Election of Board Officers:**

- Due to the resignation of our President and Treasurer, we need to fill the executive board positions.
- Various discussions took place including nominations, duties of positions, length of duties (until next election), etc.
- The following nomination was made:
  - Alton for Treasurer
  - Pete for President
  - Jeff for Secretary
- Motion: Alton made the motion to accept the officers as nominated.
- Seconded: By Pete.
- Vote: Vote: Passed unanimously.

**Replacement of resigned Board Members:**

- We started discussing and reviewing the names which were nominated by board members.
- During this discussion, Andrew mentioned the point of sending out a constant contact to the community to see if any other members would be interested in serving on the board until the November election.

- Motion - Andrew made the motion to send out a constant contract asking the POA if anyone wanted to be considered for the two open board positions.
- Seconded: Jeff
- The board discussed the motion.
- Vote:
  - 3 members voted for the motion.
  - 2 members voted against the motion.
- Alton will send out the draft message to the board today and after approved, this will be sent out through constant contacts to the POA today.
- Members will have until Thursday, 8:00pm to notify the board if they are interested.
- No exact meeting date and time have been confirmed for the vote due to the upcoming Easter weekend. We will have the vote no later than April 4<sup>th</sup> at 5:00pm.

#### **Email service to the board:**

- The board has two options for email service:
  - Stay with Microsoft365 at \$6.99 per account per month.
  - Migrate to Google for \$6.00 per account per month.
  - The costs have gone up and our options are limited due to new government regulations. These regulations are designed to help prevent phishing, spam and crime.
  - If we migrated to Google our system would be down 24-48 hours and take a lot of work and man hours to accomplish
- Motion: Justin made the motion to stay with Microsoft365
- Seconded: by Alton
- Vote: Passed unanimously

#### **Change the domain address:**

- Pete asked if we could change our website address to redfoxrunpoa.net from redfoxpoa.net?
  - Discussion - We would incur additional expense in registering a new domain, if it is available and then there is the work to migrate from one address to another.
  - After the discussion, the board decided to leave the domain as it is.

#### **Pcloud storage**

- Discussion: Where do we want to store our POA documents?
  - We only have Microsoft365 email service not the full suite of Microsoft products.
  - We could use Google Drive if we switched email servers.
  - Alton and Justin have been looking into our storage needs and possible solutions.
  - Their recommendation is Pcloud which works similar to Dropbox.
  - He believes it only costs a couple hundred dollars for a lifetime membership.

- Alton and Justin will check into this and get back with us.

### **On-going ARC Issues:**

- Pete made a proposed solution: that the president and ARC Chair meet with each individual property owner involved as well as David Traffie, to come with a solution which would include time to fulfill the commitment and bring into compliance.
- Various discussions about situations and issues.
- Motion by Alton to approve Pete.
- Seconded: by Andrew
- Vote: Passed unanimously

### **ARC Chair**

- Motion: Alton nominated Jerremy Miller for ARC Chair
- Seconded: by Pete
- Discussion by board
- Vote: Passed unanimously

### **ARC Emails**

- The board discussed the possibility of the Board being copied on all ARC emails. This is just to ensure all items are being handled in a timely manner.
- The board will not respond to ARC emails.
- Everyone agreed.

### **Road Paving:**

- In a previous discussion, Pete discussed the background on the road committee surrounding this year's paving.
- Pete also discussed:
  - The cost savings of using a local company. Prince Paving is about \$138.00 cheaper than S&J Paving.
  - Prince Paving residential paving numbers less than S&J Paving and per sq/yard were in line with the POA numbers per sq/yard.
  - Pete said that in 2023 we spent about \$45,000, this bid is \$5,000 less.
- Jeff read the balances from the March 1<sup>st</sup> treasures report: \$40,010.20 (road maintenance account) and \$25,321.39 (operating account)
- Motion: Pete made a motion to accept Prince Paving's bid of \$40,000 to pave this year's road sections.

- Seconded: Alton
- Vote: Passed unanimously
